Conventional Treaty settlements include a historical account which details the ways that the Crown breached the Treaty and provides context for the Crown Apology. Both the Crown and the claimant group must agree on these. For the Parihaka Reconciliation Process however we are referring to the historical account as a Legacy Statement. While it will include aspects from historical accounts already referred to in other settlements it will be Parihaka centred. It will also address 20th century issues and Parihaka aspirations for the future. The Legacy Statement will also form part of a Deed of Reconciliation to be signed at a Ceremony and will be included in Parihaka Legislation.
