## **CULTURAL DEVELOPMENT PRIORITIES OF PARIHAKA**

## **Background**

In 2015, Manatū Taonga commissioned John Coster, Antoine Coffin and Shirley-Marie Coffin to prepare the Parihaka Cultural Development Report ("the Report"). The Report writers subsequently identified nine priorities from within the Report for the purposes of the Kawe Whakamua reconciliation process and in particular the next phase of assessments. The costings associated with the assessments will provide some detail for Cabinet to approve a support package for the Parihaka Reconciliation process. The Report writers' initial selection of priorities were as follows:

- 6. Intellectual Property
- 8. Archaeological Processes
- 9. Building Assessment
- 12. Heritage Database
- 15. Communication Package
- 16. Website Development
- 31. Education/Conference Centre

On 18 Jul 2016, the Parihaka Papakainga Trust ("the Trust") identified their own key priorities within the Report as a part of the assessment phase. Those were clearly linked to the Needs Analysis - Parihaka Pumou and the earlier recommendations of Kawe Tutaki. Clear priorities were identified and are strongly linked to others from within the Report which should form part of the assessment to be undertaken by OTS, Manatū Taonga and the Report writers. Office of Treaty Settlements have since asked for a sequencing of the Trust's priorities. We provide these on the proviso that they are all deemed priorities and the sequencing should not diminish the importance of each.

- **11** Building Refurbishment

- 8 7 Archaeological Processes / Preservation of Taonga
- 12, 6, 13, 14, 23, 25, 26 Heritage Database
- 15, 16, 17 Communications
- **(A)** Healing and Reconciliation: Engagement of skilled facilitators and counsellors; expert advice on historical trauma; and reconciliation wānanga.
- **(B)** Special Parihaka Legislation: Apology and Commitment to the legacy of Parihaka; Restoration of Mana and Reputation of men and women of Parihaka.
- 18 Rā o Parihaka
- 19 Reo Revitalisation
