- Papakāinga Trust are developing a Code of Conduct to keep our people and kaupapa safe



ROLE OF PAPA KĀINGA TRUST

- Doesn't negotiate a deal with the Crown
- Co-ordinates and facilitates assessments and identification of priorities
- Accountable through Māori Land Court Charter and Terms of Reference
- Engagement with Papakāinga - Hui, wānanga, Website, Social Media, open door policy
- Decision making - Responsible Trustees for land management on Papakāinga
- Reconciliation Process – To inform, facilitate feedback



DIFFERENCE BETWEEN SETTLEMENT AND RECONCILIATION

SETTLEMENT

- Membership register based on whakapapa to iwi
- Treaty of Waitangi portfolio
- Settlement of historical claims
- Quantum based on Treaty formula
- Settlement of historical grievances (WAI claims)
- Approval of package based on vote of members
- Negotiated between appointed Crown and Iwi negotiators
- Claimant funding in advance

RECONCILIATION

- No membership register required
- Attorney-General portfolio
- Not settling historical claims - providing for future
- Funding based on assessments & needs
- Recognition for future development
- Approval of package based on inclusive feedback based process
- All Trustees & OTS use assessments and priorities as a guide for package
- Admin, engagement costs reimbursed - Trustees don't receive remuneration

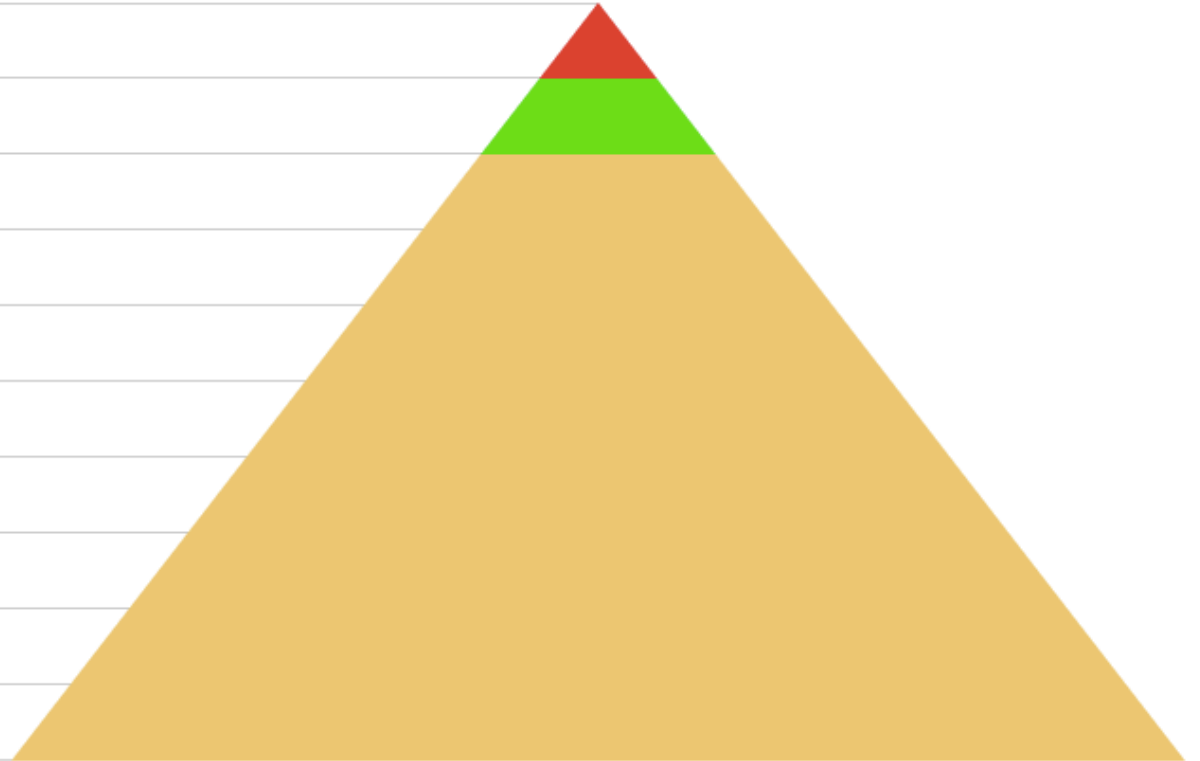

Tēnā koe

I am pleased to be able to advise the Parihaka Papakāinga Trust (PPT) of Cabinet's decisions on the Crown support package and other initiatives designed to reconcile the Crown's relationship with Parihaka. The support described below builds on the Crown's commitment in the compact of trust to further recognise Parihaka and provide a pathway for us to work together.

Relationship agreement

Cabinet has approved the Crown agency and local authority relationship agreement with Parihaka. The ten Crown parties and three local authorities involved will use their best endeavours to assist the PPT with the community's development projects. For example they will provide you with technical advice on projects and assist you with applications to the contestable funding programmes they administer. Te Puni Kōkiri will be the lead agency responsible for administering the relationship agreement for the Crown. They will be available to help you implement the agreement and will lead a review of its effectiveness after five years.

I look forward to the relationship agreement being signed at the reconciliation event planned for March 2017.

Financial contribution to Parihaka projects

Cabinet has agreed to contribute \$9 million towards Parihaka's development. This money is for the high priority projects the PPT and the community have identified, such as:

- i. land acquisition;
- ii. assistance with the water supply;
- iii. intellectual property;
- iv. archaeological investigations;
- v. healing and reconciliation support;
- vi. reviewing and strengthening governance and management;
- vii. assistance with building assessments and refurbishment;

- viii. assistance with master planning;
- ix. cultural development projects;
- x. improvements to the waste water system; and
- xi. the construction of a multipurpose centre.

In the case of land acquisition, because costs and other details were not available for Cabinet to consider, the Minister of Finance, the Minister for Māori Development and I have been delegated authority to decide exactly what assistance the Crown can provide in this area. If Crown funding is used to purchase land then it will need to come from the \$9 million Cabinet has approved. Officials will work with you over the next few months to develop a proposal for Ministers to consider. This will need to cover such things as the amount of land required and its value. If the land involved is Māori freehold land then the Māori Land Court will need to approve the transaction.

The Crown fund of \$9 million will be administered by Te Puni Kōkiri. It is proposed to pay funds out in tranches, or instalments, when the money is needed for particular developments. Officials will work with the PPT to determine the projects to be covered in each instalment, their cost and the timing for the release of funds.

The payments will be subject to reporting requirements, agreed between the PPT and officials, being met and they will be authorised by Ministers. In the case of some of the larger projects a business case will need to be completed so that both the PPT and Crown can be confident that the funding will achieve the project's objectives. Officials will be able to provide advice on what a business case will need to cover.

I propose that the Office of Treaty Settlements (OTS) works with the PPT to explore sources of private and philanthropic funding that may be available for Parihaka. I hope such funding will supplement the Crown's contribution and enable you to complete more of the developments you wish to undertake. I would be grateful if you would let me know your views on this proposal.

Other reconciliation initiatives

Cabinet has also approved a number of other important reconciliation initiatives:

- i. 'deed of reconciliation' which will build on the compact of trust, describe the Crown support package and set out any other matters we agree upon. The deed will be signed at the reconciliation ceremony planned for March 2017;
- ii. a Crown apology and historical account. OTS will work with you on the wording of the apology and historical account. I propose that the apology be made at the reconciliation ceremony;
- iii. Parihaka legislation which will include the historical account, apology and any other elements agreed between us. Cabinet has agreed that the legislation can be drafted in both English and Te Reo Māori. The legislation will be drafted by Parliamentary Counsel Office (PCO) and OTS will arrange for you to meet the drafter to discuss exactly what the legislation should cover. OTS will liaise with you and PCO throughout the drafting process. I would like to have a framework

for the legislation and much of the detail agreed by March next year and a bill ready for introduction to Parliament by mid-2017; and

- iv. a Parihaka-Crown relationship forum which will provide for ongoing, high-level, discussions and a strengthening of our relationship. Te Puni Kōkiri will be responsible for organising the relationship forum.

Kawo Tutaki and PPT recommended that the Crown and Parihaka look at ways to mark and promote the legacy of Parihaka. I understand that you have recently proposed that the Crown agree to a Parihaka Day as part of this reconciliation process. I will meet with the Minister for Māori Development, Hon Te Ururoa Flavell, to discuss Parihaka Day as soon as possible and I will let you know our thinking on this proposal following our meeting.

Next steps

I hope the Crown support package and other reconciliation initiatives will be accepted by the Parihaka community. However, I understand that this is a significant step for the community to take and that you will need time to discuss it. Please let me know the outcome of your discussions.

Finally, I want to thank the PPT for the positive approach you have taken to engaging with the Crown. I appreciate the patience and leadership you have shown in getting us to this point. I look forward to continuing to work with you on the Crown-Parihaka reconciliation process.

1. CROWN APOLOGY



● 1 Apology:

- The Crown wish to offer a formal Apology to Parihaka for its Treaty breaches and the impact its actions had on our tūpuna and their uri.
 - Apology be given by the Governor General as a direct representative of the Queen at a Reconciliation Ceremony.
 - Apology will form part of a Deed of Reconciliation to be signed at the Ceremony and will be included in Parihaka Legislation.

2. LEGACY STATEMENT

- Unlike a historical account in Treaty Settlements which details the ways that the Crown breached the Treaty “if” agreed by the Crown.
- The Parihaka Legacy Statement will include aspects from historical accounts already researched but will be Parihaka centred and tell Parihaka's story.
- Will address 20th century issues and Parihaka aspirations for the future.
- Will form part of a Deed of Reconciliation to be signed at the Ceremony and will be included in Parihaka Legislation.

3. LAND ACQUISITION

- Current Parihaka Papakāinga reservation is made up of 19 hectares.
- Not sufficient for future development.
- An additional 180 acres will assist with future developments.
- Without additional lands advancements for Parihaka's infrastructural, cultural and social needs will be limited.
- Options for the purchase of land are currently being investigated with the Parihaka community and Office of Treaty Settlement Officials.
- Any purchase would come out of the \$9 million Crown funding

4. CULTURAL DEVELOPMENT

- Parihaka and the Crown have worked on an assessment of cultural development opportunities for Parihaka's future.
- Cultural development is a vital building block for Parihaka's advancement of their aspirations.
- We have asked in the Feedback Forms for you to rank and prioritise cultural development opportunities for Parihaka such as: Intellectual Property; Building Assessments and Restoration; Multi-purpose Centre; Healing and Reconciliation

5. INFRASTRUCTURE

- Parihaka and the Crown have worked on an assessment of infrastructure priorities essential to Parihaka's future development.
- Lack of adequate infrastructure continues to be a barrier to Parihaka's day to day and long term productivity and sustainability.
- We have asked in the Feedback Forms for you to rank and prioritise infrastructure support for Parihaka such as: Housing; water; electricity supply; internet services etc.

6. RELATIONSHIP AGREEMENT

- Ten Crown agencies along with New Plymouth District Council, South Taranaki District Council and Taranaki Regional Council have agreed to enter into a Relationship Agreement with Parihaka.
- Those parties to the agreement will commit to assisting Parihaka with technical advice on projects and assist with applications for contestable funding.
- Te Puni Kōkiri will be the lead agency available to help Parihaka implement the agreement and review its effectiveness after 5 years.

7. RELATIONSHIP FORUM

- The Parihaka Crown Relationship Forum will provide for ongoing, high-level discussions and a strengthening of the relationship between Parihaka and the Crown.

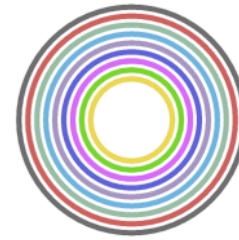
8. CROWN FUNDING

- Cabinet has agreed to a fund of \$9 million towards Parihaka's development.
- It is a starting point it will never account for the full loss Parihaka have suffered as a result of Crown actions.
- This money is for high priority projects that Parihaka will identify.
- The funds will be paid in tranches when the money is needed for particular developments.
- Safe and prudent principles, policies and processes will be set up and agreed before any expenditure takes place.

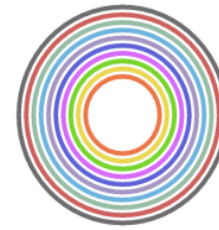
9. DEED OF RECONCILIATION

- It will include the Crown Apology and Legacy Statement and will also describe the Crown commitments to Parihaka and set out any other matters agreed on.
- It is proposed that this Deed be signed at the Reconciliation Ceremony planned for March 2017.

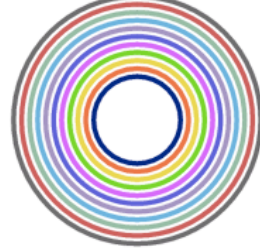
10. PARIHAKA LEGISLATION

- Parliament will pass a law to make the Crown's commitments to Parihaka legally binding.
- The legislation will include the Crown Apology, Legacy Statement and any other elements agreed.
- The legislation will be drafted in te reo Māori and english and will be agreed by March 2017 and ready for introduction to Parliament by mid-2017.

- The role of the Parihaka Papakāinga Trust is to: administer, maintain and develop property of the Parihaka Papakāinga Trust on behalf of its beneficiaries and the followers of Tohu Kākahi and Te Whiti o (Erueti) Rongomai.
- 19.6070 hectares of land is set aside as a Māori Reservation under the Māori Land Court.
- The Trust are limited in their powers to meet all of the aspirations and identified developments for Parihaka into the future.
- A review will need to take place to see what changes can be made to the current organisational structure so it is the appropriate vehicle into the future.
